### M50 Concession Ltd.'s Environmental Policy Statement

M50 Concession Ltd (M50CL) is the company responsible for the M50 PPP (Public Private Partnership) Project under a contract signed with Transport Infrastructure Ireland (TII) (formerly the National Roads Authority) in 2007. The M50 PPP Contract comprises the design, construction and financing of 24 km of the M50 Motorway as well as the operation and maintenance of the M50 in its full length for a period of 35 years. M50 Concession Ltd's offices are located in Luttrellstown Road, Tinseltown, Castleknock, Dublin 15.

M50CL recognises and acknowledges its responsibility for protecting the environment against any negative impact that might result from its Operation and Maintenance (O&M) activities. In support of this policy, M50CL will ensure that, in all O&M activities, environmental aspects and impacts will be assessed and addressed to minimise effect to the environment. M50CL will carry out all its O&M functions with due regard to the environment and to environmental requirements pertaining to O&M as set out in the M50 PPP Contract, in particular, Contract Schedules 7 and 10 and associated Annexes and Appendices. In the design, planning and execution of all (O&M) works, M50CL will take all such action and do all such things necessary to ensure that the risk of adverse effects on the environment, on the Amenities enjoyed by the Owners and Occupiers of Adjacent Areas, to Users and to the Users of Connecting Roads, is minimised in so far as is reasonably practicable. To provide a further framework of support for this policy and to ensure delivery of its objectives, M50CL operates an Environmental Management System (EMS) that is in compliance with ISO 14001:2015 EMS standards.

In support of this policy M50CL will:

- Prevent pollution and protect the natural environment from harm and damage as a result of our activities as far as is reasonably practicable.
- Determine our Company compliance requirements and obligations.
- Comply with all relevant environmental legislation, regulations, directives and codes of practice as a minimum standard and meet Industry 'best practice' standards of operation.
- Minimise usage and wastage of all natural and man-made materials, particularly of non-renewable resources.
- Co-operate with local authorities in the promotion of environmental protection.
- Ensure environmental aspects of the work are assessed for each activity and work location and decisions taken to control potential impacts.
- Ensure the protection of species and conservation of their habitats as far as is reasonably practicable.
- Educate and influence employees in environmental awareness and application of good environmental practice in all O&M activities.
- Provide environmental training and information to all staff including field operations staff and subcontractors.
- Seek positively to influence suppliers and customers in environmental awareness and protection.
- Work with sub-contractors and suppliers to improve environmental performance when relevant to O&M.
- Promote sensitivity of archaeological sites, deposits and cultural features.
- Strive for continual improvement by setting objectives to enhance our environmental performance.
- Review this policy annually and consider the need for any amendment due to changing circumstances.
